Member shall choose to retire or delete the membership with The Studio/Event Space with a 30 day written notice prior to membership termination.

#### **9. Governing Law**

This Agreement shall be construed under and governed in accordance with the laws of the Georgia.

#### **10. Arbitration.**

Any dispute arising under this contract shall be resolved under the commercial arbitration rules of the American Arbitration Association.

#### **11. Limitation of Liability**

Member shall not hold The Studio/Event Space responsible for other Members content, actions or inactions.
